

The promotion/clearance of the above officials shall be governed by the following terms and conditions:

1. Without prejudice to the seniority claim of others, if any, and without prejudice to the outcome of the writ petition(s) pending before any competent court of law.
2. The concerned Controlling Officers/DDOs will extend the benefit of promotion to the eligible officials only after verification of their Academic/ Technical qualification certificates from the concerned quarters.



3. There should be nothing outstanding against the officials. The benefit of order shall not be extended to those officials who are involved in any case of embezzlement/ misappropriation of govt. money or have behaved at any point of time, otherwise un-becoming of a govt. servant.
4. Any official aggrieved of this order has a right to represent within a period of (14) fourteen days before this office through their respective Controlling Officers/ DDOs under the provisions of CCA Rules along with documentary evidence in support of their claim.

The regularization in respect of the following officials has not been considered against the pay as sanctioned to the posts of JAEO whose APRs/ Integrity certificates has not been submitted by the concerned DDOs/Controlling Officers and therefore their Regularization shall remain on hold till scrutiny of the records is ascertained.
