1. The appointments are subject to checking/verifying/authenticating the genuineness of all **original documents** qualification/Date of Birth/Marks Certificate/State Subject Certificate/Category Certificate, Technical/Professional Certificate from the concerned Departments and production of Character and Antecedents Certificate from Additional Director General of Police, CID J&K and if on verification, the certificate produced by the appointees are proved fake or forged, the appointment shall be cancelled abinitio.

2. The appointments will also be subject to outcome of any writ petition(s) pending in any competent court of law.

3. The appointees shall initially be on probation for a period of five years and after completion of five years their services shall be declared as permanent subject to passing


of such tests, or successfully undergoing such training, as provided under the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956 or as prescribed under the relevant recruitment rules governing the post/services to which he has been appointed.

4. The appointee shall have to necessarily work during period of probation on the post against which he has been appointed and such appointee shall not be eligible transfer for whatsoever the reason.

5. During the period of probation, the appointee shall be entitled to the minimum scale of pay along with the grade pay applicable to the post against which he is appointed in terms of SRO 202 of 2015 dated 30.06.2016.

6. Every appointee shall after completing of five years period on probation be entitled to fixation of pay in the time-scale of pay applicable to the post against which he is appointed.

The appointees will join their duties in this Directorate within a period of 21 days from the date of issue of this order. In case, any appointee does not join within the stipulated time period his appointment shall be deemed to have been cancelled abinitio without any further notice to the candidate(s).
