The appointee shall report to his place of posting within a period of (21) twenty one days from the date of issuance of this order. In case, the appointee not join within the stipulated time period his appointment shall be construed that he has foregone his appointment and accordingly be deemed to have been cancelled ab-initio without any further notice to the candidate.

The DDOs shall draw salary of incumbent only after production/authentication report of following certificates/documents from their concerned issuing authorities as required under rules.

- a. Academic/Technical qualification certificates.
- b. Matriculation (Date of Birth Certificate).
- c. Health Certificates issued by concerned Chief Medical Officer of the District.
- d. Domicile Certificate issued by the Competent Authority.
- e. Certificates from District Industries, Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self-employment scheme has been availed by the appointee.
- f. Valid relevant Category Certificates, if any applicable.

The appointment shall be cancelled ab-initio, if it is found that the candidate is having qualification than the prescribed one at any stage later on and he/she shall also be liable for action under law.

The appointee shall be on probation for a period of 02 years.


