- Whereas, a complaint has been received in this Directorate that Mr. Nazir Ahmad Yattoo has abused his official position as I/c SDAO Beerwah and is involved in financial bungling in Sub Division Beerwaha in connivance with Mr. Farooq Ahmad Ganie, Sr. Asstt.; and
- Whereas, Mr. Nazir Ahmad Yattoo I/c SDAO Beerwah has transferred daily rated workers vide his No. SDAO/Estt/20-21/189-91 dated 10/6/2020 which is beyond the bounds of his competence;
- Whereas, transfer order issued in favour of daily rated workers vide No. SDAO/Estt/20-21/189-91 dated 10/6/2020 is recinded.

Now, in exercise of the powers conferred under schedule 1-B of J&K CSR Vol-II , Mr. Nazir Ahmad Yattoo, transferred as I/c SMS Beerwah, is placed under suspension with immediate effect and will remain attached with Dy. Director Agriculture (Central) Kashmir

Mr. Farooq Ahmad Ganie, Sr. Asstt. Sub Division Beerwah is attached with Directorate of Agriculture Kashmir.

Mr. Syed Washim Ahmad Shah, Dy. Director Agriculture (Central) Kashmir and Mr. Mohammad Yousuf Bhat, Section Officer Directorate of Agriculture Kashmir will probe the allegations leveled against Mr. Yattoo and furnish their findings to this Directorate within a weeks time.


