
Whereas, on the recommendations of J&K Service Selection Board made vide No: SSB/Secy/Sel/2022/6308-18 dated 21-10-2022 read with APDs Communication No: Agri/Cord/06/ 2021 dated 29-10-2022, and after receiving the provisional character and antecedents verification from CID Department, appointment orders have been issued to 43 selected candidates, out of 47 selected candidates, vide different references against the post of Plant Protection Operator/Farm Supervisor/Bee-Keeper/Field Assistant in the pay level of L-2 (19900-63200) in this Department. The Character and antecedents verification in respect of remaining 04 candidates from CID Department has not been received by this Directorate till date, and;

Whereas, out of these 43 selected candidates, 07 selected candidates, did not join this Department within stipulated time period of 21 days, therefore, their appointment orders for the Plant Protection Operator/Farm Supervisor/Bee-Keeper/Field Assistant in the pay level L-2 (19900-63200) was liable for cancellation as per the rules and conditions as laid down in the appointment orders.

Whereas the appointment orders in respect of 07 candidates were cancelled *ab-initio* vide Agriculture Order No: 66/Esstt of 2023 dated 23-02-2023 and 183/Esstt of 2023 dated 27-05-2023.

Whereas, as per sub rule 7 of rule 14 of J&K Civil Services Decentralization & Recruitment Rules-2010 notified vide SRO 375 of 2010 waiting list is to be operated, and the next selected candidate (s) is to be called for further course of action.

Now therefore, the following seven candidates appearing in the waiting list are hereby informed to report to this Directorate within 07 days along-with all the testimonials failing which it shall be presumed that they are not interested in joining in this department for Government Services.
