On the recommendations of J&K Service Selection Board made vide above cited reference and in light of Provisional Character and Antecedent report furnished by the Criminal Investigation Department J&K received by this office through IT Coordinator vide No :Agri/IT/2022-23/74 dated 31.01.2023 Miss. Kreetika Kangotra D/o Vijay Kumar R/o Gole Pully Talab Tillo Jammu (SC) is temporarily appointed as Field Assistant Grade-III/Equivalent (District Cadre Srinagar) in the pay level -2 (19900-63200) with immediate effect.

The appointee shall report to Director Agriculture Kashmir, within a period of 21 days from the date of issuance of this order failing which his appointment shall be deemed to have been cancelled ab-initio without giving any further notice in terms of the Circular No: 08-JK (GAD) of 2019 dated 04-12-2019 issued by General Administration Department.

The appointee shall be allowed to join only on production of the following certificates (in original) to be verified subsequently.

- i. Academic Qualification Certificates.
- ii. Matriculation (Date of Birth Certificate).
- iii. Health Certificate.
- iv. Domicile Certificate.
- v. Scheduled Caste Certificate.

Further the appointment shall be subject to fulfillment of following conditions:

- a. The appointee has to obtain Verification Rolls (V-Rolls) as available through online mode under the Employment Verification System (EVS) as the clearance received from the Criminal Investigation Department, J&K is provisional.
- b. Any false information provided by the appointee or any adverse findings subsequent to the V-Roll submitted electronically shall result in cancellation of appointment without any further notice.
- c. Appointee shall furnish an Undertaking on Affidavit as per Annexure-A to this Order;


- d. The salary of the appointee shall not be drawn and disbursed to her unless genuineness of Qualification/Date of Birth/Relevant Category Certificate and Final Character & Antecedents Report is received from the concerned issuing Authorities/Agency.
- e. The appointee shall be on probation for a period of two years.
- f. The appointment of the candidate shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
- g. The inter-se-seniority of the appointee in the Department shall be determined as per the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
- h. The appointment of the above appointee shall be subject to outcome of writ petition(s), if any, pending before Competent Court of law.
- i. The DDO concerned shall obtain an affidavit from the appointee regarding the condition laid down in circular No: 06-JK (GAD) of 2023 dated 06.02.2023.
